SUMMARY: This report is a request for expenditure on inventory for the Town Hall to support the facilitation of the education of the climate and ecological emergency as recommended by F&GP on 29/08/2019 min no 136/19 and endorsed by Council on 19/09/19 min no 152/19 and asks the committee to review in accordance with good practice.

 a) The Council is committed to control and manage its financial affairs in accordance with The National Association of Local Councils (NALC) guidelines.

- 3. To authorise the RFO to vire £2,600 from High Street Reserves to Equipment Purchases budget code 7702 to cover the costs.

INTRODUCTION

Hythe town Council declared a climate and ecological emergency at a meeting of full Council on 19/09/2019 min no. 152/19.

Due to indoor Covid restrictions to enable the commencement of the facilitation of the provision of information and education of the climate and ecological emergency it is envisaged that activities from outside the Town hall in the Town Hall's Undercroft can start with a view to moving the activities into the Town Hall once Government restrictions have been lifted.

To aid the set up and introduction of the project some additional furniture will be required so that Councillors and residents alike can remain Covid safe.
