Subject PLAY EQUIPMENT UPDATE F&GP/21/22

**SUMMARY:** This report provides information on the completed playground repairs and current works for the repairs of the outdoor gym equipment at Reachfields and repainting of the play equipment at Peregrine Close.

## INTRODUCTION

# **Playground Maintenance**

Folkestone and Hythe District Council (FHDC) Grounds maintenance team are contracted to make weekly inspections on all Hythe Town Council (HTC) Playgrounds. A more thorough inspection is also conducted by Wicksteed Playgrounds on an annual basis. The Finance and Project Officer along with the Pavilion Caretaker have also taken basic training in Playground Inspections so that they can ensure that any maintenance issues are confirmed, and risk assessed. Following this, under delegated powers, the Town Clerk ensures that any repair works are completed swiftly to avoid any risks to the public.

Below is a list of recent works:

#### Reachfields

Gym Equipment - Repairs were required and quotes were obtained. The supplier of the equipment has been instructed to make the necessary repairs as some of the equipment was non-functional at a cost of £827 plus vat. This will be costed to the Playground Equipment Repairs cost centre.

#### **Hythe Green Playground**

The crawling tunnel play equipment had seven missing timber logs, shingle scattered around the equipment and the green turf surface damaged. The council's grounds maintenance contract with Folkestone & Hythe District Council includes maintenance of the playground surfacing. Following the request to the district to carry out the repairs, they have provided the supplies and repairs of the crawling tunnel play equipment at Hythe Green playground at no extra cost.

The team basket swing and one of the flat swings were both damaged this year and needed to be removed to prevent further damages. Both equipment were sent to Folkestone & Hythe District Council to investigate if they were able to repair, unfortunately the parts that needed to be replaced are out of stock, no further updates have been received from the District Council. It is likely both equipment will need to be newly replaced, the Finance and Projects officer is gathering quotes for the replacement.

### **Peregrine Close**

Three quotes have been gathered from three contractors for the repainting of the play equipment at Peregrine Close. The play equipment is in need of new paint. This will be costed to the Playground Equipment Repairs cost centre.

#### Listed works to be done:

- Allow to cone off area of equipment to be decorated
- Allow to clean and rub down areas of equipment ready to be decorated
- Allow to apply paint to all areas of the equipment in colours to best match the existing
- Allow to keep area taped and conned off for the duration of the planned works and remove on completion
- On completion leave site clean and tidy

The gym equipment at Reachfields is currently non-functional and repair works has been scheduled including works for repainting. The repainting of the play equipment at Peregrine Close is recommended as the original paint has faded.
