Subject PEREGRINE CLOSE PLAYGROUND REPAIRS

F&GP/38/22

SUMMARY: This report provides information following the recent annual playground inspection on the Peregrine Close playground. The inspection report stated numerous problems on the play equipment and recommended to be repaired.

REASON FOR RECOMMENDATION:

The Committee is asked to agree the recommendations set out below because;-

a) The Council is committed to control and manage its financial affairs in accordance with The National Association of Local Councils (NALC) guidelines.

RECOMMENDATIONS:

- 1. To receive and note the report F&GP/38/22
- 2. To appoint a contractor to repair the play equipment at Peregrine Close
- 3. To cost the playground repairs from the Playground Repairs cost code

The recent annual play inspection for Peregrine Close playground identified many problems with the current state of the play equipment. It was recommended by the inspection report to carry out repairs to prevent the users from further damaging the equipment.

The Council agreed to have the play equipment repainted as at F&GP min no. 234/22 on 24 November 2022. It would be ideal to have the necessary repairs to be carried out first and then have the play equipment repainted. The contractor chosen to repaint the equipment has agreed to wait for further notice once the repairs have been completed.

Three quotes have been gathered from three contractors for carrying out repairs on the play equipment at Peregrine Close. This will be costed to the Playground Equipment Repairs cost centre.

About the Contractors and Quote Price

Contactor A - £2,859.46 plus vat

The Contractor did not include adjusting the gate, removing OXO barrier to fit correctly and repairing of the surfacing.

SUMMARY

The play equipment at Peregrine Close is in need of repairs, the playground has not been maintained for many years and signs of wear and rotting has occurred. For health and safety reasons, it is recommended to complete the repairs as soon as possible.

RISK MANAGEMENT

A summary of the perceived risk follows;

Perceived Risk Council does not repair or replace play equipment, residents would not be able to use the equipment and an accident happens or the equipment becomes rusty and looks tired.

Risk High Likelihood Low Preventative Action Council repair play equipment.
